NARRATIVE

On Thursday, February 19th, 2009, at 3:00pm, I, PO TOWNSEND, was advised by PO BRUMBAUGH that he responded to Pilgrim Park Middle School, located at 1500 Pilgrim Parkway, to investigate an incident involving a student claiming to have found a gun. PO BRUMBAUGH advised me that school personnel reported overhearing a student make statements of finding the gun in a gutter and was going to threaten someone with it. PO BRUMBAUGH stated the student was not currently at school and identified him as SMR. LT HENNEN instructed me to follow up on the incident.

I made contact with SMR's father, [REDACTED], via telephone and advised him I was investigating an incident involving his son that occurred at Pilgrim Park Middle School. I requested [REDACTED] respond with SMR to the Elm Grove Police Department so I could interview SMR about the incident. [REDACTED] stated that SMR was currently at a wrestling tournament at Pilgrim Park Middle School. I advised him I would respond to the school to make contact with SMR and afterward contact him via telephone to explain the incident in more detail.

At approximately 3:30pm, PO DONEY and I responded to Pilgrim Park Middle School. Upon arrival, I made contact with Principal, Michael SERENO in the main entrance. I advised SERENO I was there to investigate the incident involving SMR making statements about a gun. SERENO stated SMR was currently in the gymnasium and he would escort him to me. PO DONEY and I next met with SMR in the school conference room, along with SERENO present. I inquired of SMR if he knew why we were there. SMR stated it was probably because he was talking about a gun in school. I inquired of SMR what gun he was talking about. SMR stated a broken water gun he found in a gutter. I asked SMR if he had any access to real guns and if his father owned any guns. SMR stated he had no access to any guns and his father did not own any guns or keep any guns in their house. I inquired of SMR why he was making statements about the gun and threats of using it against someone. SMR stated it was a joke he started a month ago which he impersonates scenes from a video game (Grand Theft Auto) and he had no intentions of harming anyone. I stressed to SMR the seriousness of making statements of threats with guns in schools, similar to yelling bomb in an airport, or a fire in a theater, and further advised him of the consequences he could face from making such statements. SMR stated he understood, and he was extremely apologetic for his behavior. I advised SMR I would be taking no further action against him, although the school would possibly be handling disciplinary actions. SERENO then advised SMR he would be removed from the wrestling team and other disciplinary actions would be enforced. SERENO advised me he would contact [REDACTED] to respond to the school to pick up SMR. Based on the interview with SMR, it was determined he did not possess a gun at any time at school.

I next made contact with [REDACTED] via telephone, and advised him of the incident involving SMR. I inquired of [REDACTED] if SMR had any access to guns or if any where kept in their house. [REDACTED] assured SMR has no access to guns
