SUMMARY

On listed date and time, I, PO HAWKINS responded to Pilgrim Park Middle School (PPMS) for a report of a student, ██████████, who was found in possession of a weapon (knife) on school grounds. During my interview with ██████████, he admitted to carrying the weapon for an approximate week and needed it for protection. The PPMS principle, Donald C GALSTER, advised the main reason he contacted us was due to a prior incident with ██████████ which involved ██████████ threaten to bring a gun in to school to "shoot" another student and believed this incident required our assistance. ██████████ was given a suspended leave of absence from the school for that incident. ██████████ was taken into custody for CCW and transported to EGPD. ██████████ was booked/processed and issued a Municipal Citation for Carrying Concealed Weapon. ██████████ was then released to his mother, who responded to our department.

NARRATIVE

On Tuesday, June 3, 2008, at 3:04pm, SGT KUBIAK and I, PO HAWKINS, responded to Pilgrim Park Middle School (1500 Pilgrim Parkway) in reference to a student who was being detained in the principals office for carrying a knife.

Upon our arrival, I contacted the principal, Donald C GALSTER. At approximately 2:00pm, GALSTER advised one of his guidance counselors, Cindy CALEATOF, advised him a student had approached her and reported that a seventh grade student by the name of [REDACTED], had told other students he was carrying a knife. GALSTER stated when he learned of this information he responded to [REDACTED] locker to see if the said knife was there; however, he did not locate it. At approximately 2:20pm, GALSTER stated he removed [REDACTED] from his classroom to speak with him. GALSTER stated he asked [REDACTED] if he had anything on his person, but [REDACTED] just remained silent. GALSTER stated he again asked [REDACTED] if he had anything on his person, this time he replied "Yes." GALSTER requested [REDACTED] to empty the items from his pants pocket, which he complied. GALSTER stated [REDACTED] removed what he believed to be an approximate four inch in length silver utility tool, containing an approximate two in a half inch knife from his pants pocket. GALSTER stated he asked [REDACTED] if he was telling other students he had a knife, which he replied "Yes," for protection in his neighborhood. GALSTER stated he understood the actual knife length (tool type) was small and he probably would have handled this incident themselves. However, due to a previous incident (April 21, 2008 at 2:35pm) involving [REDACTED] for threatening to bring in a gun to school to shoot a female student because he was angry with her, he felt todays incident should now be handled by the police. [REDACTED] stated he was only kidding/joking when he tolds his friends and female student. However, the female student believed it to be a serious threat. GALSTER also stated [REDACTED] admitted he was in possession of the utility knife for approximately one week. GALSTER further stated he had [REDACTED] write a brief statement, which advised he was only carrying the item for his protection and that he was never going to pull it out (See attached witness statements).

SGT KUBIAK and I then interviewed [REDACTED] in a separate conference room connected to the main office. During the interview (which was digitally recorded), [REDACTED] admitted carrying the knife for approximately one week while at school. [REDACTED] stated the only reason he was carrying the knife was for his protection around his neighborhood. However, [REDACTED] stated his neighborhood was somewhat "quiet," but was afraid "someone would get at me." [REDACTED] admitted he told his friends he was carrying a knife and showed it to them, but never unfolded it. [REDACTED] also stated he carried the knife in his left front pants pocket. [REDACTED] further stated he received the knife from his friend "Maurice," while they were at his residence (Brookfield). I then asked [REDACTED] if he was aware carrying such an item on his person while attending school was illegal, which he replied, "Yes." I examined the knife and noted it appeared to be a "Leatherman" type utility tool. I also noted while it was folded (closed) it was approximately four inches in length and with the name "Alltrade" embroidered on its side. I then opened the

item and noted numerous attached tools, including a pair of pliers, screw driver, and a approximate two in a half inch cutting blade (knife). I then confiscated the item. At approximately 3:46pm, I advised [REDACTED] he was under arrest for Carrying a Concealed Weapon while at school. I then searched [REDACTED] person, with negative finding. Due to [REDACTED] cooperation, he was not handcuffed. SGT KUBIAK and I then escorted [REDACTED] to my marked squad, where he was placed in the rear seat and seat belted. I then transported [REDACTED] to the Elm Grove Police Department, followed by SGT KUBIAK.

Upon my arrival, I escorted [REDACTED] from the sally port into the booking room. With PO DONEY's assistance, [REDACTED] was fingerprinted and photographed. I then issued [REDACTED] Wisconsin Uniform Municipal Court Citation and Complaint N656108, for violation of Elm Grove Ordinance 147-2, entitled Carrying a Concealed Weapon, with a mandatory Municipal Court date of July 2, 2008, at 4:00pm. I escorted [REDACTED] from the booking to the front lobby of the Police Department, where we made contact with his mother [REDACTED]. I then explained to [REDACTED] the citation I issued to her son, including the mandatory court appearance, which she stated she understood. At approximately 4:39pm, [REDACTED] signed the Elm Grove Police Department "release of juvenile" accountability form, at which time her son was released into her custody. I then placed the knife and recorded interview with [REDACTED] (Compact Disc) in to property inventory as evidence.
